## Agricultural Lime Procurement Form



Users will be entering their information into <https://pulp.mdf.coop/>. To set up your account, please contact Courtney A at 701-671-1333 or 701-591-9962 or Josh K at 701-671-7787 or 701-552-1546. Point of contacts will be available from **8AM –4PM** (Monday – Friday). Loading hours will be updated daily on the website. Anyone wishing to receive lime from Minn-Dak must be on our “approved list of lime haulers”. To be added to the “approved list of lime haulers” the following must be provided:

- Name of person/entity hauling the lime (print please): \_\_\_\_\_

  1. Once registered, users will receive a username and password to login to Minn-Dak’s lime website (<https://pulp.mdf.coop/>). There, users will be required to book their lime loads for the day. To do so, click on ‘Available Loads’. Choose the number of loads you are anticipating hauling. Submit the request. Load information is located under the ‘My Loads’ tab. Including load number information. This number will not change throughout the day.
  2. The user needs to enter into the app the approximate number of loads that they are anticipating receiving for the day.
  3. Reference the loading map for entry gate E5, scale location, lime loading area, and exit gate E6.
  4. Upon arrival, notify security at the scale house **701-671-1350**. This will notify our loading team.
  5. At entry gate E5, haulers will fill out a load ticket and the control sheet. There, haulers will provide their name, ticket #, and load number.
  6. Once through the entry gate, proceed to the lime loading area. Carefully follow the loading map.
  7. Once loaded, return to the scale house and turn in the top copy of your load ticket.
  8. There will not be a loading fee charge.
  9. It is the hauler’s responsibility to make sure all loads are secure. No material is allowed to leak or spill during transportation. (Solid Waste regulations Minn. R. 7035.0800, subp. 3 Collection and Transport of Solid Waste, Spills)
